1.	20.01.2015	Crime Branch of Chandigarh Police arrested 05 bookies who were indulged in gambling activities on Cricket Matches. There were complaints that some gamblers are indulging in the Tricity and they are playing and planning to cheat the innocent public by the way of alluring them to put their money on the forthcoming Cricket World Cup-2015. A case FIR No. 17 dated 20.01.2015 u/s 420,120-B IPC and 4&13-3-67 Gambling Act has been registered in Police Station Sector-19, Chandigarh has been worked out.
2.	12.02.2015	Crime Branch developed secret information that 03 accused persons namely Sanjog Kumar, Sonu Dhane and Sanju were frequently involved in Auto lifting in the tri-city. During the course of investigation, 08 stolen Motor cycles and 03 stolen scooters were recovered on their disclosure solving 11 cases of auto theft registered with different police station of the city.
3.	23.02.2015	Crime Branch of Chandigarh police have arrested five persons and break the nexus of officials of Car dealer agencies, banking officials along with other persons, who got approved the loan for brand new vehicles on the basis of fake and forged documents and sold out the same to the different purchasers and as such they caused wrongful loss lacs of rupees to the banks and the general public. A case FIR no. 54 dated 18/02/2015 u/s 419/420/467/468/471/474/120-B IPC, Police Station-31, Chandigarh. During the course of investigation all together 11 vehicles have been recovered from the possession of accused as well as purchasers which were procured by the above said accused from the different car agencies by obtaining loans on fake and forged documents and further sold some of vehicles to the innocent buyers and the detail of recovered vehicles is as under:- DUSTAR- 2, MARUTI SWIFT-3, ALTO- 2, ETTOS CROSS-1, BALERO PICK UP-1, HYUNDAI I-20, 1MOHINDERA, VERITO-1
4.	31.03.2015	Crime Branch of Chandigarh Police apprehended 02 persons and recovered 150 boxes (1800 bottles) of Beer make Kingfisher from a vehicle bearing registration no. HR-68-6250 (Mahindra Pick-up) with them any legal permit/permission. The said consignment is being smuggled outside Chandigarh. A case FIR no. 164 dated 31.03.2015 u/s 61-01-14 Excise Act, PS Manimajra, Chandigarh was registered in this regard.
5.	08.04.2015	Crime Branch of Chandigarh Police apprehended 02 persons and with their arrest succeeded to crack a gang who used to rob jewellery and money from the school children by beating and showing artificial gun and on the pretext to protect them from other school children. Both the accused were arrested on 07.04.2015 and recovered Rs. 4500/- and one gold ring from their possession. A case FIR No. 108 dated 07.04.2015 u/s 392, 34 IPC, PS – 17, Chandigarh was registered in this regard.
6.	23.05.2015	The Crime Branch of Chandigarh Police succeeded in apprehending an accused namely Emmanuel Chukwunonye s/o Oforka of Nigerian, while he was in possession of 28 gms Cocaine without any license or permit. A case FIR No. 168 dated 23.05.2015 u/s 21 NDPS Act, has been registered in PS – 17, Chandigarh
7.	01.07.2015	In a major breakthrough, Crime Branch of Chandigarh Police arrested one person namely Mukesh Kumar s/o Sh. Pankaj Kumar r/o H.No. 703, Village Hallo Majra, Chandigarh Permanent Address Village-Sapohi, Post Office-Kaushila, PS-Bodh Gaya, Distt-Gaya, Bihar who was indulged in preparing fake Aadhar Cards. After verifying the facts, a case FIR No. 189 dated 30.06.2015 u/s 420, 467,468 IPC, PS-31, Chandigarh was registered in this regard. Fake Aadhar Card and equipments i.e. CPU, Printer, Scanner and other materials which he was using to prepare fake Aadhar Cards were also seized from his institute.
8.	28.07.2015	The Crime Branch of Chandigarh Police succeeded in apprehending two inter-state drug peddlers namely Manzoor and Mazid Hassan both resident of Distt Anantnag, Jammu & Kashmir while they were carrying 500 gms Charas without any license or permit.
9.	03.08.2015	Crime Branch developed a secret information that 02 accused persons namely Manoj Kumar s/o Sh. Ramesh Kumar r/o Village-Devipura, PS-Bhojpur, Distt-Muradabad, UP, age about 32 years and

		Mukesh Kumar s/o Late Sh. Ram Niwas Singh r/o Village -Garha, Post Office & PS-Dhanari, Distt-Sambhal, UP, age about 25 yrs were frequently involved in Auto lifting in the tri-city. During the course of investigation, 13 stolen two wheelers were recovered on their disclosure which led to solving of 10 cases of auto theft registered with different police station of the city
10.	08/08/2015	Crime Branch of Chandigarh Police conducted raids on the premises of Hookah Bar at the Kasbah Lounge, SCO No. 47, back side showroom, Sector-26, Chandigarh & SCO No. 19, Cafeena-26, Sector-26, Chandigarh which are owned by Love Gupta and Amit Verma, respectively. Dr. Deepak Bakshi of GMSH, Sector-16, Chandigarh and Drug Inspector were also accompanied the police team. Large numbers of Hookah Consumers were found sitting in both the premises. During checking, samples of all the relevant articles including different flavours, which were used in hookahs were taken into possession with the help of Drug Inspector after sampling
11.	23.08.2015	Crime Branch of Chandigarh Police arrested Rojia @ Sony R/o Village-Dialpura, Zirakpur, Distt. Mohali (Pb) from Green Belt, Dividing road, Sector-45 C&D, Chandigarh and recovered 7 Gram of Heroin from his possession. A Case FIR No. 420 U/S 21 NDPS Act has been registered in PS-34, Chandigarh.
12.	06.09.2015	Chandigarh Police (Crime Branch) arrested Harjit Singh R/o # 348, Sector-45-A, Chandigarh near Community Centre, Sector-45, Chandigarh and recovered 25 Gram of Heroin from his possession. A Case FIR No. 443 U/S 21 NDPS Act has been registered in PS-34, Chandigarh.
13.	21.09.2015	Chandigarh Police (Crime Branch) arrested Pawan Kumar R/o # 2356, MWT, MM, Chandigarh near Bus Stop, IT Park, MM, Chandigarh and recovered 250 Gram of Opium from his possession. A Case FIR No. 510 U/S 18 NDPS Act has been registered in PS-MM, Chandigarh. Further investigation is going on.
14.	07.10.2015	Crime Branch arrested Arvind Kumar R/o # 2760, Sector-37-C, Chandigarh near Govt. Model School, Sector-37, Chandigarh and recovered 12 Gram of Smack from his possession. A Case FIR No.417 U/S 21 NDPS Act has been registered in PS-39, Chandigarh. Further investigation is going on.
15.	20.10.2015	<p>Crime Branch manned a trap near Petrol Pump, Sector-52, Chandigarh and succeeded in arresting accused namely Sanjeev Kumar and Rehmat Ali along with stolen Motor Cycle having registration No. PB65-M-3412 make Platina Bajaj and Activa having registration No. CH01-AD-2289, which were stolen vide FIR No. 377 dated 01.10.2015 u/s 379, 411 IPC, PS-36, Chandigarh &amp; FIR No. 246 dated 05.07.2015 u/s 379,411 IPC, PS-36, Chandigarh, respectively. During the course of investigation, they have disclosed that they have stolen number of two wheelers from Chandigarh. Both the accused were produced in the court on 19.10.2015 and obtained 02 days police remand. During the course of investigation, 11 stolen two wheelers were recovered on their disclosure which led to solving of 8 cases of auto theft registered with different police station of the city.</p> <p>In the second incident, Crime Branch succeeded to arrest a notorious inter-state gold chain snatcher namely Dilshad s/o Badhi Shah R/o H.No. 32/3, Raipur Kalan, Chandigarh. On 14.10.2015, a naka was laid down near Railway Quarters, Mauli Jagran, UT/Chandigarh and recovered one gold chain from his possession which was snatched in case FIR No. 427 dated 25.08.2015 u/s 379, 356, 452,411 IPC, PS-34, Chandigarh. He was produced in the court on 15.10.2015 and obtained 04 days police remand. During interrogation, he disclosed that he along with one Vicky of Delhi had snatched number of gold chains from different places in the area of U.T.,Chandigarh. With the arrest of accused Dilshad, so far total 06 cases of snatching out of which 05 of gold chains and 01 mobile phone have been worked out on his instance.</p>
16.	01.11.2015	In a major achievement the Crime Branch of Chandigarh Police managed to arrest Abrar Khan s/o Ishmaile Khan r/o Village Bholupur, Distt. Dabriya (UP), an under trial who alongwith four under trial accused persons managed to escaped from the Judicial Lock-up, District Court, Sector-43, Chandigarh. The accused was arrested from Airport Light Point. The accused was riding on motor cycle which was stolen from the area of Panchkula. This is the second arrest made by Chandigarh Police, With the arrest of accused Abrar Khan the following three cases have been worked out:-

Surjit Singh r/o House No. 732, Sector-40 A, Chandigarh from sector-41, after he had managed to escape from police station sector-34, Chandigarh. The accused was earlier arrested from sector-45, Chandigarh while he was carrying 7 grams Heroin. A case FIR No. 514, U/S 223, 224 IPC and FIR No. 512 U/S 21 NDPS Act registered in PS-34.</p>
17.	04.11.2015	<p>In a major achievement, the Crime Branch of Chandigarh Police managed to arrest accused Joginder Singh s/o Sh. Ram Kishan r/o Village Hatt, PS Saffidon, District Jind, Haryana, who is a Proclaimed Offender in number of criminal cases of Chandigarh and Haryana. On 03.11.2015, on a tip-off, the team of Crime Branch laid a naka at roundabout Sectors 24/25/37/38, Chandigarh and apprehended above said accused while he was coming from the side of Sector-25, Chandigarh. He was arrested in case FIR No. 106 dated 06.04.2006 u/s 365,382,384,323,506,120-B IPC, PS-39, Chandigarh in which he was declared as proclaimed offender by the trial court.</p>
18.	21.11.2015	<p>Crime Branch arrested Manoj Kumar R/o # 606, Sector 38-A, Chandigarh near light point, Sector-25/38, Chandigarh and recovered 5 gram of Heroin from his possession. A Case FIR No. 469, U/S 21 NDPS Act has been registered in PS-39, Chandigarh. Further investigation is going on.</p>
19.	16.11.2015	<p>Crime Branch of Chandigarh Police arrested Shane Alam s/o Jane Alam r/o Village &amp; Police Station-Kiratpur, Mohalla-Mustian, District-Bijnour (UP) and Mohd Sazid s/o Mohd Gaffar r/o H.No. 144, near Ramaiya Public School, Mohalla-Kajipada, District-Bijnour, (UP). Accused Shane Alam escaped alongwith other three under trial accused persons from the Judicial Lock-up, District Court, Sector-43, Chandigarh on 23.09.2015. 20.	24.11.2015	<p>Chandigarh Police (Crime Branch) arrested Rajiv Kumar @ Raju R/o # 55, Dashmesh Enclave, Dhakoli, PS-Zirakpur (Pb) near Cremation Ground, Daria, Chandigarh and recovered 7 Gram of Heroin from his possession. A Case FIR No.361 U/S 21 NDPS Act has been registered in PS-Ind. Area, Chandigarh. Further investigation is going on.</p>
21.	29.12.2015	<p>Crime Branch of Chandigarh Police has succeeded to arrest a burglar namely Jatin aged about 25 yrs s/o Sh. Shankar r/o Village-Pach Bhaiya, PS-Rajganj, Distt-Uttar Dinapur, West Bengal and recovered 25 mobiles of different makes and one laptop from his possession.</p> <p>The facts of the case are that on 16.12.2015, Sh. Ghansham Bhardwaj s/o Ashok Kumar r/o H.No. 2031, Pipliwala Town, Mani Majra, Chandigarh reported about the burglary of new mobiles by breaking open the locks of his shop M/s Mobile and Electrics Works at shop No. 21, Gali No. 3, Shanti Nagar, Mani Majra, Chandigarh. A case FIR No. 669 dated 16.12.2015 u/s 457,380 IPC, PS-MM was registered in this regard.</p> <p>On 28.12.2015, on a secret information, a team of Crime Branch apprehended accused namely Jatin aged about 25 yrs s/o Sh. Shankar r/o Village-Pach Bhaiya, PS-Rajganj, Distt-Uttar Dinapur, West Bengal and recovered 02 mobile phones from his possession on the spot which were found to be stolen in the above said case.</p> <p>During the interrogation, he has disclosed that he alongwith his accomplice has had committed number of burglaries especially on electronic shops in the area of Chandigarh. During the further investigation, 23 more mobile handsets of different makes and a laptop were also recovered on his instance. Out of these 23 mobile handsets, 14 mobile phones found to be stolen in the above said case and the remaining 11 mobile handsets and laptop are being verified from where he</p>

		<p>had stolen the same.</p> <p><u>Modus Operandi</u></p> <p>The accused belongs to West Bengal and presently residing in the area of Mani Majra, Chandigarh. He is a drug addict and used to steal electronic items by breaking the locks of different electronic shops along with his accomplice. He is in practice of selling stolen mobile handsets on the lower/cheaper rates to the students and other needy persons in order to fulfil his drug requirement.</p> <p>Further investigation is going-on and some more recoveries are likely to be effected.</p>
22.	30.01.2016	<p>In a major success, Crime Branch has succeeded to apprehend the kingpin of the gang namely Inderjit @ Inder s/o late Sh. Raju r/o H.No. 287, I-Block, Tigri Camp, New Delhi from Ambedkar Nagar and recovered a car having registration No. DL3C-DZ-2007 and some equipments/articles i.e. oil, pointed edge weapon (sua), some iron balls and air diffused device from his possession which they used for executing the crime</p> <p>So far, cash Rs. 4.50 lacs, a car make I-20, one Activa and some equipments used in the crime have been recovered from his possession solving the following cases:</p> <ol style="list-style-type: none"> <li>1. FIR No. 26 dated 14.01.2016 u/s 379 added 411 IPC, PS-17, Chandigarh</li> <li>2. FIR Nol. 417 dated 22.11.2015 u/s 420, added 411 IPC, PS-36, Chandigarh</li> </ol> <p><u>Modus Operandi</u></p> <p>The accused persons are originally belongs to Tamil Nadu state and presently residing at EWS Colony in Delhi. They used to visit tricity on weekly and fortnightly basis to commit the crime by using the car and two wheelers. First they made raccie on two wheelers of the places from where the people carry heavy cash. When the victims carry cash bags in their vehicle, the accused persons followed them and they stopped the vehicle by getting the tyre punctured and thereafter they split oil at front portion of the vehicle and by deceiving the victims they robbed the cash bags and as such they committed number of crimes in the tricity and other states of India and looted lacs of rupees. After committing the crime they again shifted to Delhi by dropping two wheeler involved in crime in a local busy parking and took away car with them to Delhi.</p>
23.	11.02.2016	<p>On 11.02.2016, Crime Branch of Chandigarh Police received a secret information that two persons namely Ranbir s/o Ramesh Chand r/o Janta Colony, Naya Gaon, District Mohali and Vijay s/o Khaleel Nath r/o Jhuggi, Shastri Nagar, Mani Majra, Chandigarh are in illegal sale of 'double-headed wonder' snakes in the area of UT/Chandigarh on very high rates to the innocent persons and presently they are present at the back side of BDC, Sector-26, Chandigarh.</p> <p>On this information, the Wild Life Department, Sector-19, Chandigarh was intimated and requested to join the team of Crime Branch to arrest the snake sellers. After joining the team of Wild Life Department, Sector-19, Chandigarh, a raiding team was constituted. A bundle of papers having two notes of Indian currency of 500/- rupees denomination was prepared and handed over to the decoy customer and necessary instructions were given to him. The decoy was sent in a ground located at the back side of Bapu Dham Colony, Sector-26, Chandigarh to struck a deal with the above said persons. As per the instructions, the decoy customer finalized the deal with the snake dealers in Rs. 15 lacs for one snake and handed over the prepared bundle of notes of Rs.50,000/- to them as advance money. On receiving the signal from the decoy customer, the team of Crime Branch alongwith the team of Wild Life Department acted swiftly and apprehended both the accused along with a bag. On asking, they disclosed their names as Ranbir s/o Ramesh Chand r/o H.No. 953, Janta Colony, Naya Gaon, Punjab and Vijay s/o Khaleel Nath r/o Jhuggi, Shastri Nagar, Mani Majra, Chandigarh.</p> <p>On search of the bag, three 'double-headed wonder' (two mouth snakes) of brown and red colour of SAND-BUA breed were recovered. The bundle of money which was handed over to</p>

		<p>them by decoy was also recovered. On this, case FIR No. 37 dated 11.02.2016 u/s 9, 44, 52, 49B-1, 51 of Wild Life Protection Act-1972 and 420 IPC, PS-26, Chandigarh was registered. During investigation, both the above said accused were arrested.</p> <p>Modus Operandi Accused Vijay is permanent resident of Sonipat, Haryana and belongs to a Nath Community. He used to capture the snakes especially SAND BUA breed from the jungle areas of Haryana, UP and Rajasthan and sell the same at high rates with the help of other associates to the needy persons who prepare the drugs/medicine especially to improve the sex power. The accused was arrested from his native village-Paras Rampura, Rajasthan. This is the arrest of fourth accused by the Crime Branch and with this arrest, all four escaped accused have had arrested. Earlier, the team of Crime Branch had succeeded to arrest absconding accused Pankaj, Abrar Khan and Shane Alam. Accused Vicky @ Rajasthani found involved in dozen of robbery, snatching and theft cases. On 11.02.2016, accused was produced before the Hon'ble Court and obtained two days police remand. 24.	1.3.2016	<p>Accused Arrested by Crime Branch</p> <p>There was spurt increase in the incidents of robbery/snatching/auto-theft in the City. As per the briefings given by the senior officers, a special campaign was organized by the Crime Branch of Chandigarh Police to target the robbers/gangs of such modus operandi. Even reliable informers were deployed for the collection of intelligence and technical help was also taken. On a specific input, a trap was laid by Crime Branch to nab the culprit on 28.02.2016 naka near Lake, Village Dhanas, UT/Chandigarh and succeeded in apprehending two members of a robbers gang namely Sagar (king-pin) and Suraj who robbed the people/passengers during night hours by using stolen three wheeler/car and two wheeler in the tricity.</p> <p>The said gang on the night intervening 08/09.02.2016, the members of the above gang snatched a three wheeler bearing Registration No. PB-65R-2327, mobile and cash of the auto-driver from the jurisdiction of PS-39, Chandigarh and after that they robbed valuables articles from three persons at different places in city regarding which case FIR No.22 dated 09.02.2016 u/s</p>																						

		<p>392/511 IPC, PS-11, Chandigarh, case FIR No.23 dated 09.02.2016 u/s 392, 34 IPC, PS-11, Chandigarh, case FIR No.25 dated 09.02.2016 u/s 392/34 IPC, PS-36, Chandigarh and case FIR No.12 dated 09.02.2016 u/s 382 IPC, PS-49, Chandigarh were registered.</p> <p>During preliminary interrogation, they confessed that besides these incidents, they have committed number of robberies/snatchings/auto-thefts in the area of Chandigarh with the help of their associates namely Surjit and Shankar. Both the accused were arrested in case FIR No.22 dated 09.02.2016 u/s 392, 511 IPC and FIR No.23 dated 09.02.2016 u/s 392, 34 IPC, both of PS-11, Chandigarh and produced before the Hon'ble Court of Sh. Aman Inder Singh, JMIC/Chandigarh and obtained three days police remand.</p> <p><u>Modus Operandi</u></p> <p>All the accused are drug addicts and residing in the slum areas of Chandigarh and having past criminal record. Accused Sagar is in the list of Most Wanted Criminal of Chandigarh Police. They especially operate during the night hours for committing robbery/snatching/vehicle theft. They used to steal two-wheelers, autos and four-wheelers from the area of UT/Chandigarh. After executing the crime, they used to left the stolen vehicle in the busy parking lots or in the jungle areas. They first identify the person going alone and carrying valuable articles and then attacked upon him with lathis &amp; sharp edged weapons. Sometimes, they pick the persons as passengers from Bus Stand, Railway Station etc on the stolen vehicle and took them to the deserted places for committing the crime. They spent the looted/robbed money for fulfilling drug requirement and lavish lifestyle. After identifying the vehicle, first they break open the driver side window glass with screw driver and then they opened the bonnet by pulling bonnet button. After opening the bonnet, they removed the battery wire to disconnect the central lock and after that by opening the door, they unlock the steering with a drill machine. They used to move the vehicles few yards and then they fitted ECM and Electronic Scanner (special instruments to change the programming of vehicle) and lock set by removing the original one to make the programming of the vehicle changed. In this way, they succeeded in starting the vehicle and took the same to Delhi and after tempering the same, the sell them in big markets just to make easy money for enjoying lavish life style.</p>

There was spurt increase in the incidents of gold chain snatching cases in the area of UT/Chandigarh. The senior officers constituted a special squad of the officials of Crime Branch headed by Inspector Ranjit Singh to analyse the modus operandi and to ensure arrest of the criminals involved.

In this context, a special campaign was organized to target snatchers. On 05.08.2016, on a tip off, a team of Crime Branch had laid a naka near Kali Mata Mandir, Dhanas, Chandigarh and during checking they have arrested on accused namely Sanjeev Kumar @ Deepu s/o Rishi Ral r/o H.No. 1553, DMC, Chandigarh age 31 yrs and recovered one gold chain from his possession. He had snatched the said gold chain near H.No. 1012, Sector-15/B, Chandigarh regarding which a case FIR No. 114 dated 20.01.2016 u/s 379, 356 IPC, Chandigarh was registered in PS-11, Chandigarh.

During interrogation, he had confessed that he alongwith his accomplice Shishpal @ Kalu and one another has snatched number of gold chains from the different locations at Chandigarh and used different make bikes for committing the same.

He was produced before the Illaqa Magistrate on 06.08.2016 and obtained 04 days police custody remand. During further investigation, his accomplice Shish Pal @ Kalu has also been arrested. So far, with the arrest of both accused, total 03 gold chains and one motor cycle have been recovered and 04 cases have been worked out

Modus Operandi

Both the accused belongs to slum areas and are unemployed. They are habitual of playing gambling. Accused Shishpal @ Kalu having previous criminal record and found previously involved in about 15n cases of vehicle and house theft. They used to steal motorcycle and then snatched the gold chains by identifying the alone aged men/women during morning and evening times. They used the money from the stolen gold chains for playing gambling and fulfilling the lust of drinking and smoking etc. Investigation is in progress which expected to be more recoveries of snatching cases.

Today, accused will be produced before the Hon'ble Court and police remand will be obtained. Further investigation is in progress and some more recoveries are likely to be affected.

**Most notorious gang of snatchers and vehicle thieves arrested**

In a major breakthrough the Crime Branch of Chandigarh Police under the supervision of Inspector Amanjot Singh arrested the most notorious gang of snatchers and vehicle thieves.

1. Vicky s/o Late Sh. Joginder Singh r/o House No. 1200, Sector-46/B, Chandigarh. Age 31 years. **(Date of arrest 7.10.2017)**
2. Usman Ali s/o Meharban Ali r/o V-92, Welcome Silampur- III, near Photo Chowk, Distt. Shahdara, Old Delhi-53, Age 32 years. **(Date of arrest 10.10.2017)**
3. Shakil Ahmad S/o Mohamad Gaphar R/O V-86 Welcome Silampur, Photo Chowk, Distt. Shahdara New Delhi, Age 40 years. **(Date of arrest 10.10.2017)**

During the interrogation of these accused it has been revealed that they are involved in several cases of gold chain snatchings and vehicles lifting in Chandigarh and from them Anti Snatching, Robbery and Dacoity detection cell of Crime Branch is able to solve total 17 cases out of which 13 are of gold chain snatchings and 4 cases of vehicle theft.

The modus operandi of these criminal is that they used to target ladies wearing gold chains preferably older in age, who are pedestrian and by making excuse of asking the location of particular place, they used to divert once mind and then suddenly get close to the target to snatch their gold chains and after committing the crime they used to flee on the motorcycle from the spot.

These accused tried hard to sell these gold chains in Chandigarh and around, but failed to do so, as no jeweler accepted to this illegal sale and most of them demanded bills for these gold chains.

All the accused persons were snatching gold chains and keeping these chains with them with the intention that they will soon get a disposing point where they can sell these snatched chains.

Accused Vicky had tented past and last year in the month of October 2016 he was arrested and at that time he was proclaim offender in 45 cases and total more than 100 case of snatching, robbery, motor vehicle theft were registered against him. Some of cases are under trial and in some cases he got convicted.

During the interrogation of these accused it has been revealed that they are involved in several cases of gold chain snatchings and vehicles lifting from Chandigarh and from them Anti Snatching, Robbery and Dacoity detection cell of Crime Branch is able to solve total 12 cases out of which 7 are of gold chain snatchings and 1 case of gold ear Tops snatching and 4 cases of vehicle theft.

Both the arrested Naman and Subham are real brothers and are permanent resident of Jalandhar. The modus operandi of these brothers is that they used to target ladies wearing gold chains or ear rings who are pedestrian. They usually snatch chains during the day time and immediately after the snatching they used to go to Mandi Gobindgarh (Khanna) and from where they buy narcotics from one of the paddler. They used to hand over the snatched chains to the paddler, one such chain and stolen motor cycles has also been recovered from this paddler namely Gurdeep Singh.

All the accused persons have a tainted past as all of them have been arrested in different cases of narcotics, motor vehicles theft and snatching earlier by Punjab Police. Both these brothers committing crime of snatching recently in Jalandhar and when they have been identified by the Jalandhar Police they left the Jalandhar city and started living in Chandigarh as paying guest in H.No. 99, Sec.20, Chandigarh. While living Jalandhar they had stolen one splendor bike from Jalandhar Railway Station bearing registration No. PB08BL-2994 and this bike they further used in snatchings. This bike has also been recovered.

From them four mobile phones which they have got financed on fake I.Ds i.e. Aadhar Card and PAN Card were recovered while they were going to sell these phones in Mobile Market Sec.22, Chandigarh alongwith few fake I.Ds. All these four accused were produced before the court and their four days police remand was obtained.

During the course of investigation another three accused involved in this gang members were also arrested on 20.1.2018 i.e.

1. Amit Katyal s/o Monohar Singh Vill. Badhera, Teh. Haroli, Distt. Una.

From them fake I.Ds used by them for procuring loan were also recovered.

**Modus Operandi:**

That Amit Katyal and Kapil Dhingra used to work in HDFC Bank and Bajaj Finance Ltd. respectively, both of them used to steal the data of the prevailing loan customers and further provide this data to one Baldev Kumar who used to prepare their fake I.Ds i.e. Aadhar Cards and PAN Cards and on the basis of these fake I.Ds Sanjeev Gupta, Aashish and Shakti Singh got huge amount of mobile phones financed from Bajaj Finance, HDFC Bank and Capital Finance and further they used to sell these finance phones in the local market on a cheaper price, the money obtained after the sale of such mobiles was distributed among all of them.

From the investigation so far it has come to notice that these cheaters were not only doing such cheating for their own benefits but also causing huge loss to the customers of such financing companies whose data has been provided to them by Amit Katyal and Kapil Dhingra, as the installments of these cheated phones is being deducted from the account of such people who even don't have the knowledge of any such loan and the installments if not paid their account is going to fall in the category of bad loan.

By unearthing such scam the Crime Branch of Chandigarh Police not only nabbed the real culprits but also saved the innocent people from being the victim of financial embezzlements.

Sanjeev Gupta, Baldev and Sakti Singh have tainted past, Sanjeev Gupta was arrested earlier by PS-Ind. Area, Chandigarh in Cheating case, Sakti Singh was arrested by Cyber Cell, Chandigarh in cheating case and Baldev Singh was arrested by Mohali Police in snatching case.

On 25.2.18, secret information was received that above said accused persons who is involved in several cases of vehicle lifting is presently roaming in the area of Police Station Sector 3, Chandigarh. On the basis of that secret information the naka was laid and Kuldeep Singh was apprehended while he was trying to steal another car from Kaimbwala. The modus operandi of accused Abhishek is that he used to Kamanidar Knife for robbing the victims. All the arrested accuseds are drug addicts and in order to fulfil their drug requirement, they robbed, snatched and lifting the vehicles in the jurisdiction of UT/Chandigarh, so that they can get the money from the stolen items.

They, all alleged in their complaints that the alleged persons have cheated them on the pretext of sending them abroad on study visa, but even after spent a long time,</p>

the alleged persons neither send them abroad nor refund the said amount. Further, during the course of enquiry, it revealed that all the complainants gave amount to the alleged through RTGS, NEFT and Cheques, but neither they send them abroad neither return their hard earned money. After coming solid evidences on enquiry file against the alleged persons, a case FIR No. 50 dated 31.03.17 u/s 420, 120-B IPC, PS-03, U.T., Chandigarh was registered against accused Arvind Ashat s/o Jagdish Singh R/o H.No. 3301, Sector 71, SAS Nagar, Mohali Punjab 2. Pupinder Sood @ Kartik s/o Sh. Jagbir Singh r/o 1269 DMC, Chandigarh, 3. Sikha w/o Nitin Sharma r/o H.No. 244 Phase-1, Mohali, Punjab. 4. Gurpreet Singh s/o Mohan Singh r/o H.No. 89, New Darshni Bag, Mani Majra, Chandigarh. 5. Jagat Singh s/o Madan Singh r/o 274, Nada Road Naya Gaon, Distt Mohali Punjab. On 31.03.2018, two accused namely Gurpeet Singh s/o Mohan Singh r/o H. No. 89, New Darshani Bagh, Mani Majra, Chandigarh and Jagat Singh s/o Madan Lal r/o H. No. 274, Nada Road Nadiala, Naya Gaon, Punjab have been arrested on 31.03.2017 and in their disclosure statements u/s 27/E Act, they disclosed that complainants/clients approached them and further they (accused) arranged the meeting with Shikha, Kartik & others, who further arranged the final meeting with the main accused namely Arvind Ashat accordingly and further settle the amount to be paid by the complainants/clients. Thereafter, the alleged persons received the settled amount from the complainants/clients by cash, through RTGS etc on the pretext of processing fees, college fees, medical fees, Embassy Fees etc in respect of sending them abroad. During the course of investigation, lot of people i.e., total 373 people approached investigation officer and also provided him their complaints regarding cheating them by accused Arvind Ashat and his wife Tanisha Ashat etc.

After found no way to escape, accused persons approached Hon'ble High Court for anticipatory bail. The Hon'ble Court has passed interim orders on 20.4.2017, therein the counsel for the alleged assured that the petitioner/alleged would disburse the due payment to the said victims after obtaining the receipt and return of the documents, if any earlier executed by petitioner for refunding the amount and that the petitioner further intends to return the amount received from the different victims numbering almost 163 as per the list provided by the police prepared in the course of investigation, but the petitioner required time for returning the amount and also the documents furnished by the said victims to the police in the court of investigation were to be verified and also ascertained by the petitioner in the course of joining of the investigation and the petitioner would make the payment of victims in the batches of 20 each after a gap of fifteen days for each batch. That, it is also pertinent to mention here that the fourth complainant in the present case namely Kesar Singh visit in the police station, who verbally disclosed that the counsel of the alleged have gave him part payment cheque, which has again bounced and the alleged person did not give his complete amount. That, it revealed that the alleged person is misleading the Hon'ble Court by assuring that he would refund the said amount, but no any complainant/victim come forwarded before the investigating agency who assured that the alleged person had refund their amount. In between, complainants also made request before Hon'ble Punjab and Haryana High Court for transfer the investigation to CBI with the allegations that officials of Police Station did nothing in this case. The next date of hearing of this case is fixed for 07.05.2018 for status report.

On 04.04.2018, in view of the importance of case, senior officers constituted a Special Investigation Team (SIT) under the close supervision of DSP/Crime for investigating the case on priority. A team headed by SI Jaivir Singh under the close supervision of undersigned worked dedicatedly day and night and issued Look Out Circular against both the main culprits Arvind and Tanisha Ashat as well as freeze almost all the bank accounts and bank lockers of alleged, obtained bank records and conducted a lot of raids at their possible hideouts i.e., in Amritsar and Mohali area

and as a result of their hard work, on 26.04.2018, members of SIT succeeded in rounded up both main culprit of this case Arvind Ashat and Tanisha Ashat from Mohali, Punjab. Further, during the course of investigation, the vehicle of accused containing documents pertaining to the crime, stamps of their company and related documents have been recovered at their instance.

### Cases registered

Recently on 4.8.2018 a complaint was received that someone has installed two external devices i.e. skimmer and spy camera in the Canara Bank ATM machine which is installed in SCO No. 117-119, Sec.17, Chandigarh. On the basis of this complaint the case FIR No. 262 dated 8.8.2018 u/s 420,511 IPC PS-17, Chandigarh got registered. In this regard the CCTV Footage installed in the ATM Room was examined and it has been found that two different persons are fitting these external devices to sneak the data of the ATM users. Similar complaints were received in Police Station Manimajra i.e. case FIR No. 339 dated 06.08.18 u/s 66 (C) 65D IT Act 420,511 IPC and Police Station Sec.36, Case FIR No. 287 dated 04.08.18 u/s 420,511 IPC Chandigarh.

### Information collection

Keeping in view the gravity of the crime, Crime Branch of Chandigarh Police collected information about such persons and on the basis of the information collected from the sources, it has come to notice that it is handy work of an International Gang and the persons who were involved in pilferage of ATM Data by using spy devices are Romanian Nationals. Further on the basis of this information entire record of the persons who visited in India in recent days were collected and on the basis of this record, it was established that two such persons namely Miclea Lecian Lonut and Paraschiv George Aletandru resided in the Hotels in Chandigarh i.e. Metro Sec.35 (Check-In Date 2.8.2018 Check-Out date 2.8.2018) and Western Court, Sec.43, Chandigarh (Check-In date 2.8.2018

and Check-Out date 5.8.2018) Western Court (Check-In date 7.8.2018 and Check-Out Date 7.8.2018).

Further more information was developed and it has been established that both these persons were residing in Vasant Kunj, New Delhi, on this information the team was immediately sent to New Delhi and these two persons who were residing in Hotel Glitz Westend Inn, NH-8 adjoining Shiv Murti Mahipalpur, Ranguri, New Delhi were arrested and brought to Chandigarh..

**Modus operandi**

On interrogation they have disclosed they arrived in India as visitors and further arrived in Chandigarh on 2.8.2018 with the intention to collect ATM data by putting spy devices and left Chandigarh on 5.8.2018 and again visited Chandigarh on 7.8.2018 with the purpose to collect the devices installed in different ATM machines. But all the devices have already been detected by the Bank Branches and have been removed from the ATM machines. It has revealed during the interrogation that after collecting the data they use to make a clone ATM cards and further use these cards for online shopping or withdrawing money internationally. To dodge the police and to confuse the bank employee they have purchased many accessories like caps, spectacles and even one wig which was used by them while putting these spy devices in the ATM rooms, so that if their footage comes out nobody able to recognize them or the investigating agencies will get confused about the identity and the numbers of persons involved.

**Recoveries**

Caps, wig used by them for changing their outlook and the clothes worn by them at the time of fitting these devices were recovered.

**Chandigarh Police arrested one more in ATM skimmer cases**

On 14.08.18 a secret information was received that the persons who are involved in several cases of snatching and vehicle lifting presently roaming in the area of Police Station 49, Chandigarh. On the basis of secret information the naka was laid and two of them were apprehended while they were on their way to sell of one of the snatched gold chain.

**Modus Operandi**

Both the accused have been arrested several times in the past. Both of them in the jail decided to club and after getting bail they started snatching gold chains from the tri city and lifting two wheelers. They used to steal two wheelers for snatching chains and they choose their target as women specially the older one so that they cannot chase or raise alarm immediately. With the fear of being caught every time they used to change vehicle for the commission of crime and after the commission of crime they used to abandon the vehicles in the free parking areas.

**Recoveries**

1. Five Gold Chains and a Gold locket.
2. Motor Cycles = 4.
3. Honda Activa =3.
4. Four two wheeler U/s 102 Cr.P.C

With their arrest total **14 cases** were worked out. **Out of which 5 are of chain snatchings, 7 are of vehicle theft and 2 are of P.O.** Except this 4 two wheelers have been recovered from them which according to them they have stolen from Panchkula and Mohali.

Most of these snatching were done by Vicky alone on this activa and he used to give these snatched mobile to Ramesh for further selling it in the market.
