D.N Bhasin S/o Shri Nanak Chand Bhasin R/o # 202, Sector-19A, Chandigarh, reported that at about 4.30 PM he alongwith his wife gone to Chandigarh Club. When he came back at 7.00 PM and found that the main door of his house was broken and door of his room, as well as almirah and lockers were also found to be broken. Someone had burgled his house after breaking the locks and taken away cash and other articles.</p> <p>During the course of investigation, suspected person, servant, former drivers etc were interrogated. CCTVS cameras of locality as well as markets area were thoroughly checked. During checking of CCTVs footage, four suspected person were found to be roaming near the said house at the time of theft and they were</p>

also seen to come back toward Light Point sector 19/27 Chandigarh. One person was identified as former driver Heera Lal of said house.
So, on 5.8.2016 raid was conducted at his Jhuggi Indira Colony, Manimajra. He was thoroughly interrogated and confessed that he alongwith his 03 associates has committed theft at H No 202 sector 19A, Chandigarh. On his identification, co-accused Kishan @ Patra and Raj Kumar Kalia were arrested near Peer Mjaar, Dhillon Barrier, Manimajra, Chandigarh. They were arrested in the above said case. On 6.8.2016, another juvenile boy was apprehended from Barrier Naya Gaon, Distt Mohali, he is juvenile.

During interrogation accused Heera Lal confessed that, he was former driver of said house and knows that place where cash and other costly items were kept by the owner. Then he made contact with Raj Kumar Kalia for commit theft, who is residing near Peer Mjaar, Dhillon Barrier, Chandigarh. Raj Kumar Kalia further contacted with Kishan @ Patra, who daily used to visit Peer Mjaar and one juvenile who was earlier resided with Raj Kumar Kalia at Naya Gaon, Distt Mohali.

Heera Lal alongwith co-accused person has made visits of sector 19, Chd 2-3 times for before commit the theft. On 23.7.2016 Heera Lal brought them from Manimajra to sector 19 by bus. Heera Lal stand near Palika Bazar sector 19, Chandigarh and Raj Kumar Kalia, Kishan @ Patra and juvenile went in the said house. Raj Kumar Kalia and Kishan @ Patra kept iron rod in their pant and juvenile hide screw driver in his pant. The commit theft in the said house and fled away in auto with Heera Lal. They divided the cash and other stolen articles in jungle are near I.T Park. Approximately 4 Lac cash came into each share. Some cash and articles were recovered from the accused person and some cash yet to be recovered from them. During interrogation, it revealed that accused Raj Kumar Kalia was earlier arrested by GRP, Panchkula in theft case. Accused Kishan @ Patra was arrested in murder case FIR No 426/09 of PS Mani Majra and released on bail in the year 2015.
