2.	29.01.2016	<p>Chandigarh Police achieved a major success in a sexual assault/murder of a person namely Ram Variksh S/o Ram Murat resident of Housing Board Society, Sector 78, Mohali, Punjab, by arresting two person namely Satish Kumar S/o Arvind Kumar R/o Gali No. 1, Balmiki Mohalla, Burail Age-20 years and Ankit Kumar S/o Raju Rawat age-19 years from tube well Sector 50, Chandigarh within short span of 24 hours, by a team of Police Station Sector 49, under the close supervision of Inspector Ranjodh Singh SHO/PS-49, Chandigarh.</p> <p>On 27.01.2016, a message was received that a person is lying near light point of Colony No. 5, Chandigarh. After receiving this information police immediately reached the spot and take the person to GMCH-32, Chandigarh, where doctors declared him dead. A case FIR No. 5 dated 27.01.2016 U/S 302, 377, 34 IPC has been registered in Police Station-49, Chandigarh on the complaint of Sandeep Kumar against Ankit and Satish, who stated that on 26.01.2016 at about 9 PM he came to a temple in Sector 50, Chandigarh. He saw two boys dragging a person to a small building adjoining to slip road of Sector 50, Chandigarh and they tried to do unnatural sex with him. He was watching them secretly. They were addressing each other by the names of Ankit and Satish. They inserted a stick in anus of victim. On this complainant shouted and tried to stop them, consequently both accused threatened him and gave him warning that if he stay there, they will do the same with him what they did with the victim. He being alone ran away from the spot.</p> <p>During investigation both the accused person namely Ankit Kumar and Satish Kumar were arrested by the police. Investigation of the case is in progress.</p>

		<p>been registered in Police Station-49, Chandigarh</p> <p>Chandigarh Police achieved a major success in a "Attempt to Murder Case" of a person namely Sh. Ram Pal R/o # 2011-E, Block No. 23 Sector-63, Chandigarh, by arresting two ladies within short span of 24 hours, by the team of Police Station-49, under the leadership of Inspector Ranjodh Singh SHO, PS-49, Chandigarh and close supervision of Dy.S.P. Sh. Deepak Yadav, SDPO, South.</p> <p>On 13.07.2016, a message was received that there is spot of stabbing in House 2011-E, Block No. 23, Sector-63, Chandigarh. After receiving this information, Police immediately reached the spot where complainant Smt. Kamlesh Rani W/o Sh. Ram Pal met and stated that she is serving in A.G. Punjab Office Sector-17, Chandigarh and her husband has been retired from same department on 31.03.16. On 13.07.16, she had left for office in the morning and at around 5:00 PM, she came back from her duty and found the house bolted from outside, as she entered in the house her husband was lying in injured and unconscious condition near their drawing room. The house hold articles were also found in scattered condition. She doubted that unknown persons has attempted to commit robbery at their house and has voluntarily caused injury to her husband. On the statement of her, a case FIR No. 47 dated 13.07.2016 U/s 307, 394 IPC has been registered in Police Station-49, Chandigarh.</p> <p>During investigation, both the accused ladies namely Fatima Bano W/o Riyast Ali and Amandeep Kaur @ Mano W/o Maninder Pal Singh were arrested by the police and also recovered the knife (weapon) used to commit this crime, looted mobile phone and gold chain. Amandeep Kaur @ Mano stated in her statement that she met with Sh. Rampal in Sector-42, where Sh. Rampal told her that he will shift to his new residence/house in Sector-63, Chandigarh and is willing to sell his old mattresses. So, Amandeep Kaur went to Sh. Rampal's new residence i.e. # 2011-E, Block No. 23 Sector-63, Chandigarh before 3 days ago to commit this crime. From where she came to know that Sh. Rampal is living alone in day time and is aged person too. She planned in her mind all this and on dated 13.07.2016, she again came to Sh. Rampal's house along with her friend Fatima Bano W/o Riyast Ali. Sh. Rampal was alone at that time in his house. she slit with knife and looted his mobile phone, a gold chain and other household article with the help of her friend. They also tried to break the safe/Almirah but they could not. On hearing some noises from outside, they immediately left the house. On their identification, Police recovered the weapon (knife) used in crime and also recovered all looted items.</p>

20.	<b>08.03.2019</b>	<p><b><u>Murder Case solved</u></b></p> <p>Chandigarh Police got a major success in a recent murder case of Police Station Sector 49, Chandigarh in which young boy Vishal Chillar, ex-student of DAV College, Sec.10, Chandigarh was killed by the rival party due to the student politics. The joint team of Crime Branch of Chandigarh and Police Station Sector 49 cracked this case and arrested 5 main accused involved in this crime.</p> <p>Facts of the case:</p> <p>The case FIR No. 20 dated 6.3.2019 u/s 147,148,149,452,302,307,34 IPC and 25/27/54/59 Arms Act PS-49, Chandigarh was registered on the complaint of Sh. Pankaj S/o Sh. Brij Bhushan R/o # 2813/1, Sec.49, Chandigarh in which he stated that Sudeep along with his accomplice attacked on him and his friends Vishal Chillar, Aashish, Meghal and others when they were sleeping in their house. In this attacked Vishal Chillar was killed and others were got injured. The accused party fled away from the spot and injured was taken to Hospital where Vishal Chillar was declared brought dead in PGI.</p> <p>Apprehension of accused.</p> <p>Today, afternoon, an information was received that the accused who are involved in the recent firing incident at Sector 49, Chandigarh are roaming in I20 Car No. HR20-AN-0846 and probably will pass from that area boarding Panchkula and Chandigarh. About that information SHO, Sector 49, Chandigarh and his police team was informed and was joined in the police party. On that information the naka was laid near wine shop on the border of Panchkula and Chandigarh, I.T, Park, Chandigarh for checking and during checking a car I20 bearing No. HR20-AN-0846 was seen coming from Panchkula side towards Chandigarh side and on seeing the car, it was signaled to stop whereas the driver of the car on seeing the police party stopped the car and try to reverse it but the car was rounded up by the police officials available on the naka and occupants were overpowered, during their interrogation they disclosed their name as:</p> <p>Sequence of events revealed during the interrogation.</p> <p>Following this old revelry on 5.3.2019 Pankaj, Vishal and few of their friends went to New Chandigarh at the house of Sumit to beat him up and his friends, but this information was leaked by Aman Nehra @ Bachi to Sumit. On the basis of the given information Sumit alongwith his friends left the house, when the opposite party did not find them at their residence they vandalized their car No. HR48A-</p>

		<p>5500 which was parked outside their house at DLF Society, Mullanpur, New Chandigarh, this fact was also reported by Sumit at Police Station Mullanpur, Distt. Mohali.</p> <p>Pankaj and Vishal later came to know that the information of their attempt for attacking on Sumit and others was leaked by Aman Nehra and on this they confronted him and even beat him up for the same. With the vengeance in mind Aman Nehra booked cab from Sector 49 and reached at the residence of Sumit, New Chandigarh where he disclosed the entire planning of Pankaj and Vishal to the opposite party i.e. Sumit, Sudeep and others and even told them that now all of them are sleeping, the entry door of the house is open and if they go and attacked them now they can get a free access, on this Sudeep and Naveen picked up their weapon (pistols) and others i.e. Rahul Manda, Sumit, Sushil Bhola and Ramdeep took sward, Gandasa and sticks and attacked Vishal, Pankaj, Aashish and others at H.No. 2813/1, Sec.49, Chandigarh, where Sudeep fired at Vishal Chillar and Naveen followed him and also fired at Vishal whereas the other accompanying Sudeep and Naveen attacked the rest of the people sleeping in the flat. After this gruesome attacked all of them ran away in I20 car to Rishikesh and today they were apprehended while they were coming back to meet one of their friend to collect money.</p>
21.	13.03.2019	<p><b><u>Remaining accused of murder case arrested by PS-49</u></b></p> <p>Chandigarh Police successfully solved a recent murder case of Police Station, Sector-49, Chandigarh (Murder of Vishal Chillar, ex-student of DAV College, Sector-10, Chandigarh on 06.03.2019 in Sector-49) by arresting all of the seven (7) accused persons.</p> <p>On 06.03.2019, case was registered on the complaint of Sh. Pankaj S/o Sh. Brij Bhushan R/o # 2813/1, Sec.49, Chandigarh in which he stated that Sudeep along with his accomplice attacked on him and his friends Vishal Chillar, Aashish, Meghal and others when they were sleeping in their house. In this attack, Vishal Chillar was killed and others were got injured. The accused party fled away from the spot and injured were taken to Hospital where Vishal Chillar was declared brought dead in PGI.</p> <p>On 08.03.2019, 5 accused i.e. 1) Rahul Manda S/o Zile Singh, Age-21 Years R/o New Police Lines, Hisar, Haryana, 2) Ramdeep Sheokand S/o Virender Singh, Age-21 Years R/o Madhuban Colony, Ward No. 12, Barwala, District-Hisar, Haryana, 3) Sumit Kumar S/o Ranbir Singh, Age-23 Years R/o Shiv Nagar, DCM Mill Gate, Hisar, Haryana 4) Sushil Kumar S/o Bal Kishan, Age-20 Years R/o Sunder Nagar, Barwala Road Hisar, Haryana and 5) Amandeep Nehra @ Bachi S/o Ajmer Singh, Age-21 Years R/o Vikas Nagar, Hisar, Haryana were arrested and vehicle/items used in crime were also recovered.</p> <p>Yesterday, in the late evening, on receiving information that</p>



		<p>the remaining 2 accused i.e. 1) Sudeep Pahal S/o Bijender, Age-22 Years R/o Village-Bara Khurd, Near Gohana bypass Jind, Haryana and 2) Naveen Seharawat S/o Gulab Singh R/o Village-Badhmalik, District-Sonipat, Haryana will reach in Chandigarh and their movement will be through Poultry Farm Chowk, Naka was laid by the police party headed by SI Virender Singh. During checking, both accused Sudeep Pahal and Naveen Seharawat were apprehended and later on arrested after interrogation. Weapons used in the crime have also been recovered.</p>
