7.	25.8.2016	<p>In a major success, Crime Branch has succeeded to apprehend a member of the gang of dacoits namely Vinod s/o Kishra Sahari r/o Village-Tola, Teh&PS-Mazogash, District Gopalganj, Bihar age about 29 years and recovered Copper Coils total weighing 11 quintals valuing Rs. 5 lacs (approximately) from his possession.</p> <p>The facts of the case are that Sh. Nitin Sharma s/o Late Sh. Shiv Kumar Sharma r/o Village- Kirpalpur, Model Town Colony, Nalagarh, HP got registered a case FIR No. 124/2016, PS-Barotiwala, HP alleging therein that on 22.08.2016, some unknown culprits had looted Copper Coils from his factory situated at plot No. 38, Matoli Kalan, Baddi, HP by breaking open and tying the hands & legs and gagged the mouth of his guard/chowkidar.</p> <p>On a tip off, a team of Crime Branch under the close supervision of DSP/Crime as well I/C Crime Branch laid a naka near Wodden Raw Machine, Milk Colony, Dhanas, Chandigarh and succeeded in apprehending one member of a gang of dacoits namely Vinod alongwith vehicle Mahindra Pick-up having registration No. HP64-0510 in which he was carrying looted Copper Coils stolen from Barotiwala area and was on the way to sell the said material to some scrap dealers. The recovered copper coils were taken into possession vide memo after got identified the same from the complainant/owner of looted material. A case FIR No.72 dated 24.08.2016 u/s 411 IPC, PS-Sarangpur, Chandigarh was registered in this regard.</p> <p>During the course of further investigation, accused has disclosed that they had committed number of robberies/dacoity in the area of Baddi, Barotiwala and other part of Himachal Pradesh. The local police of the concerned police station of Himachal Pradesh have been informed regarding the incident and the detail of crime committed in their areas by these gangs. The other members of the gangs are at large and efforts are being made to arrest them with the help of Himachal Pradesh Police.</p> <p>Modus Operandi</p> <p>The accused persons are originally belongs to Bihar state and presently residing in the area of Barotiwala/Baddi. He alongwith his accomplices, first made raccine in the industrial area of Baddi/Barotiwala to select their target and thereafter, in the late night hours, they entered the factory by breaking open the gates of factory. If they found any guard in the factory, they used to beat them and tied them and also some times gagged their mouths. After that, they looted the different types of raw materials stored in the factory. Ravinder Singh r/o # 107/1, Near Harry Sangam Hotel, Vill. Attawa, Sec. 42, Chd. age 19 years who were active in tri-city in MV theft.</p> <p>On 01.10.17 at about 4.15 PM, one juvenile was apprehended with stolen splendor M/cycle vide FIR No. 164 dated U/s 379 IPC PS-Sarangpur from near Dhanas bridge, who was produced before JJ court and sent to Juvenile court.</p> <p>On 01.10.17 about 4.45 PM on secret information a Naka was laid by SI Kuldeep Singh of PS-Sarangpur alongwith police officials on Jayanti Majri road leading to Vill. Gopal R/o # 1557-B, EWS Colony Dhanas Chandigarh age 22 years by the team led by Insp./SHO Lakhvir Singh comprising SI Rohitash Kumar IC PP-24, SI Sukhchain Singh under the close supervision of Sh. Krishan Kumar, CPS, SDPO Central Division.</p> <p>The brief fact of the case is that Vijay Kumar S/o Prahlad Yadav R/o 476/A EWS Colony Dhanas Chandigarh age 26 yrs stated that on the intervening night 12/13.09.18 at about 11.15 PM, he was on walking with his dog outside of his house where Kuldeep @ Luvkush alongwith with his friend Vijay were already present and having Ice Cream. Mean time he saw that three persons were urinating in public place, then Kuldeep @ Luvkush and his friend raised objection for the same, and told them not to urinnate there as there is residential area. But they didn't bother and started arguing with them. One of them stabbed a knife to Kuldeep @ Luvkush and Vijay and other namely Gulshan beaten them with helmet and other slapped them. Afterwards they fled away on their motorcycle. The injured Kuldeep was taken to hospital by complainant and others and the other injured was shifted to hospital by the PCR. On the complaint of Vijay case FIR No. 245 Dated 13.09.2018 U/s 307, 34 IPC PS-Sarangpur Chandigarh got registered. During treatment injured Kuldeep was declared dead. Gopal R/o # 1557-B, EWS Colony Dhanas Chandigarh age 22 years were got apprehended from Jagadhari bus stand at about 3.30 PM. Later on both accused are arrested in present case.</p>

Model High School, RC-2 EWS Colony, Dhanas, U.T Chandigarh reported that on 17.02.2019 he went to State Bank of India, Khudda Lahora branch for withdrawal of money where after inserting his ATM Card no cash was withdrawn and thereafter he returned back. In the mean time he received a message on his mobile number about the withdrawal of amount of Rupees 20,000 from his Bank account. Upon which a case FIR No. 45 dated 24.03.2019 u/s 420 was registered against the unknown person. During Investigation on 29.05.2019 a team of PS Sarangpur headed by SHO Ram Rattan arrested accused Monu Kumar and on interrogation of accused total 22 ATM Cards of different banks in the name of different customers have been recovered from his possession.</p> <p><u>Modus Operandi</u></p> <p>Firstly Accused used to visit different ATM Booths and by one or other way they used to choose innocent/illiterate persons visiting ATM Booths and then by befooling the customer the use to know their ATM PIN number and then exchange ATM card with customer on the pretext of fault in ATM Machine. After that when the customer left from the ATM Booth they withdrew amount by using original ATM Card of customers.</p> <p>Secondly He use to hang the ATM Machine before the customer put all transactions details on machine and they use to tell the customers that the machine is hanged and when the customer left from the ATM booth they use to bring ATM machine in normal mode. They use to hang the machine by pressing Punjabi Language button in old ATM Machines.</p> <p><u>Background of Accused</u></p> <p>Accused is Middle pass and involved in ATM Fraud cases since 2016 and earlier he was arrested in the PS-Sadar (Charkhi Dadri) and</p>

		Karnal in the similar cases and he is on bail in these cases. He has committed the ATM Fraud cases in the area of Haryana, UP and Chandigarh.
13.	31.05.2019	<p><u>Vehicle theft and Mobile theft cases solved</u></p> <p>On 31.05.2019 Chandigarh Police achieved a success by arresting one accused namely Mohit S/o Anil Kumar R/o House No. 812 Phase 1 Ram Darbar, age 21 Years who is found involved in Vehicle theft and Mobile theft cases under the supervision of Insp. Ram Rattan SHO Sarangpur.</p> <p>On 31.05.2019 Mr. Vikram Kumar S/o Jagdish Lal R/o H.No. 371 Village Khudda Lahora, U.T Chandigarh, reported that his tenant Bendanilenla gave me her two mobile phones i.e I Phone 6s (IMEI 358369066356269) and HTC Desire (IMEI 359342065866462) to put the same for charging in his room and in the morning time between 5.30 PM to 6.00 AM the above mentioned two mobile phones were found stolen, thereafter he reported the matter to police. Upon which a case FIR No. 68 dated 31/05/2019 u/s 380 has been registered in PS Sarangpur against unknown person. During investigation acting on a secret information, a team of PS Sarangpur headed by SHO Ram Rattan arrested Mohit S/o Anil Kumar R/o House No. 812 Phase 1 Ram Darbar, age 21 Years from Khudda Lahora and recovered the above mentioned stolen mobile phones and further he confessed that he have stolen many mobile phones and thereafter total 20 Mobile phones of various companies have been recovered from his house. Apart from this total six two wheelers have also been recovered from the jungle area of Mullanpur and Sarangpur on his identification.</p> <p>Case solved</p> <p>With the arrest of accused Mohit, one case FIR No. 68 dated 31/05/2019 u/s 380 PS Sarangpur (Mobile theft), one case FIR No.245 dated 28.12.2015 u/s 379 PS Maloya (Active theft) and another case FIR No.23 dated 15/02/2019 u/s 379 PS Sarangpur (Activa theft) have been solved. Remaining 18 Mobiles and four two wheelers have been taken into police possession under section 102 Cr.Pc.</p> <p>Modus Operandi</p> <p>Accused Mohit is a drug addict and to fulfill his addiction he use to steal two wheelers and thereafter he use to search for open houses where he can easily enter and stole mobile phones. He was planning to sell the Mobile phones at Delhi in order to avoid his arrest. After committing offence he use to leave the stolen vehicles in Jungle area of Sarangpur and Mullanpur. He is 9th class passed.</p>

Ram Rattan SHO Sarangpur.</p> <p>On 14-08-2019 Mr. Sachin Sharma S/o Late Shyam Lal Sharma R/o # 371/17 colony no 2 Khuda Lahora Chandigarh, reported that someone has stolen away gold ornaments of his wife amounting to Rupees nearly 10 Lacs by breaking the locks of his house in the morning of 14.08.2019. When they both were on their duties and no one was present at home. He immediately informed to police upon which a case FIR No. 117 dated 14-08-2019 u/s 380,454 IPC was registered at PS Sarangpur by SI Avtar Singh. Thereafter DSP Central Sh. Krishan Kumar constituted a special team under the close supervision of Insp. Ram Rattan SHO Sarangpur and on the night of 23-08-2019 Police team nabbed accused Vineet Thapa from his house and recovered stolen gold ornaments worth Rupees 10 Lacs from his house. Today he was produced before Hon'ble Court and a police remand. During investigation he confessed another burglary case of PS 19 area.</p> <p><u>Case solved</u> With the arrest of accused Vineet Thapa one case FIR No. 117 dated 14-08-2019 u/s 380,454 IPC was registered at PS Sarangpur and another case FIR No.29 dated 04/03/2019 u/s 380 PS 19.</p> <p><u>Modus Operandi</u> Accused Vineet Thapa used to target the locked houses before committing the crime. He used to inspect the locality before committing the burglary.</p> <p><u>Previous History</u> He was earlier arrested in a case of theft at PS Naya Gaon in which he is on bail. He is originally a resident of Nepal and he is married. He is having two children's. His Qualification is 12th pass.</p>

16.	<p>09.06.2020</p> 	<p>On, 09.06.2020, Chandigarh police achieved major success by arresting two thieves and two jewelers and solved two cases which were registered at Police Station Sarangpur U.T Chandigarh and recovered gold/silver items approx one Lac, 2 LED (55 Inch and 32 Inch), 7 Cylinders, 5 Motorcycles, 1 sony camera from their possession (Approx 5 Lacs) Total recovered items approx 6 Lacs.</p> <p>On 20.04.2020, on the complaint of Surender Prashad S/o Mukut Prashad R/o 34/C Small Flats Dhanas Chandigarh, a case FIR No.58 dated 20.04.2020 u/s 380,457 was registered in Police Station Sarangpur, Chandigarh, in which he has reported that on 21.03.2020, he along with family had gone to Mohali,. On 20.04.2020 his neighbors informed him telephonically gave that lock of his house have been broken and when he reached his house then he saw that all house was ransacked and he saw that gold, silver ornaments , camera , mobile phone etc items were stolen by unknown persons.On 09.06.2020 In another case , which was registered on the complaint of Sh.Guddu s/o Bindu r/o # 794/A small Flats, Dhanas chandigarh, I.e a case FIR No. 85 dated 09.06.2020 u/s 380,457, he stated that he works at shop no. 37 kishor fruit company grain market sec 26 chd. On 15.03.2020 he went to grain market sec 26 for his work. Due to the lockdown , he stayed at the same place and his wife had gone to her house. When he back came back to his home on 07.06.2020 , he saw that the lock of his house was broken And one led samsung company , one gas cylinder , one pair of lady silver anklets one pair of child silver anklets and some other item were stolen.</p> <p>During the course of investigation, a special team in the supervision SHO Sarangpur Ram Rattan Sharma under the close supervision of SDPO/Central Krishan Kumar was constituted and they succeeded in arresting two accused namely Babloo Alias Gorila S/o Surinder Ram R/o H.No. 1755 Small Flats, Dhanas, Chandigarh, Izhar Alias Daadi S/o Sh Hasnain Khan R/o House No. 727/B Small Flats,Dhanas, Chandigarh on a secret information from near Govt model school, Dhanas, Chandigarh on 09.06.2020 in the evening. During interrogation they confessed that they have burgled many houses in Dhanas along with their two associates, who are still absconding. They also disclosed that they use to sell the stolen gold and silver items to Jewellers namely Rajan S/o Sh Shiv Ram R/o H.No 1483 Small Flats, Dhanas and Kirpa Shankar S/o Shri Ram Verma R/o H.No. 1920-B Small Flats, Dhanas,Chandigarh. On their discloser statements the above said jewelers were also arrested from Dhanas and some of the stolen gold /silver items have been recovered from their possession.
