

**STANDING ORDER NO. 80/2015**

**ORGANISATION, FUNCTIONING AND DEPLOYMENT OF INDIA RESERVE  
BATTALION, UT, CHANDIGARH**

In supersession of previous standing order No.42/2009 pertaining to India Reserve Battalion, Chandigarh, this new standing order is hereby issued in order to further streamline the functioning of the India Reserve Battalion, UT, Chandigarh, India.

**1. OVERALL HEAD:**

The IGP, UT, Chandigarh shall be the overall head of IRB, Chandigarh, who shall be assisted by DIGP, UT and Commandant, IRB, UT, Chandigarh. The Commandant, IRB, UT, Chandigarh will be responsible for the day-to-day administration of IRB, U.T. Chandigarh.

**2. AIM:**

- (i) The main aim for raising the India Reserve Battalion as per Government/MHA letter No. 16011/6/2006-PF.IV (iii) dated 23. 1.2009(appendix-A) is to make available additional force to the central government for deployment anywhere in the country, as and when required.
- (ii) The Central Government exercises the right of first call on India Reserve Battalion for deployment in other states, particularly to meet the short term requirements like Elections, festivals, natural and manmade calamities, etc. In the times when India Reserve Battalion Force has not been called by the Central Government for specific deployment outside the home state, the force is available to the state government for providing reinforcement to the district police and other agencies besides carrying out regular training.
