

TERMS AND CONDITIONS FOR THE PURCHASE OF MESS FURNITURE & UTENSILS FOR OPERATION CELL, SEC-26, CHANDIGARH.

1. Specifications of furniture items are attached as annexure-"A".
2. The shape & design should be as per master pattern of Police Department. The Master pattern can be seen at RTC Mess, Sector-26 Chandigarh on any working day.
3. The Tender should be accompany earnest money of Rs. **8500/-** in the shape of Call Deposit / Fix Deposit Receipt with each tender on any Schedule Bank only pledged in the name of the Inspector General of Police, U.T., Sector-9, Chandigarh. No tender will be accepted without earnest money and if received after **05.00 PM** on **20.03.2017.**
4. The Tender should be sent in a sealed cover marked in bold letter with ketch pen "**TENDER FOR SUPPLY OF MESS FURNITURE & UTENSILS FOR OPERATION CELL, SEC-26, CHANDIGARH AT 05.00 PM** on **20.03.2017** and addressed to the **Inspector General of Police, UT, Sector-9, Chandigarh** (with Sample).
5. The Tender received by the specific date and time shall be opened in the presence of such Tenderness who may desire to be present at _____ on _____ in the office of the **Inspector General of Police, UT, Sector-9, Chandigarh.**
6. Tender of only those firms who will quote the price of required item as per specification will be accepted.
7. The material to be supplied by the firm, If any deviation is found during the test the entire amount of EMD will be forfeited and the firm will be declared black listed.
8. Purchase committee to be nominated by Chandigarh Police can visit the site to inspect the material.
9. Earnest Money shall be valid for a period of 6 months from the date of opening of the Tender by the Purchaser. No interest will be payable by the Purchaser on this amount.
10. The Tender can be accepted /rejected by the competent authority without assigning any reason. The quantity of the items/articles can Be increased / decreased at the time of placing supply order.

11. The firm should have registered with the Sales Tax/VAT Department, with respect to Sales Tax/ VAT and shall furnish copies of the same with their Tender.
12. The supply should be completed within 45 days from the date of supply order.
13. The rate should be quoted F. O. R., destination, including all taxes, if any.
14. The Purchase committee reserves the right to relax any terms & conditions in the Govt. interest.
15. The payment will be made only when the entire supply is received and found fit for use as per the approved specifications/sample.
16. No conditional / Telephonic or Faxed Tenders will be accepted.
17. The firm shall be fully responsible in case any defect is found in the material and should be replace the defective material within **one Year.**
