

PRESS RELEASE

In a major break through a team of Police Station Sector 17, Chandigarh in the supervision of Inspector Ram Gopal, SHO-17 under the guidance of Sh. Ashish Kapoor, DSP/Central achieved a success in arresting 2 person namely Dharmbir Singh S/o Dhani Ram R/o Village-Kansal Age-23 yrs at a naka near turn Sector-22 A+B, Chandigarh on 09.03.13 at 9.30 PM and recovered yellow color Karizma M/Cycle bearing fake No. CH-01AK-2426 which was stolen from Lake down parking near street No.-5 Chandigarh vide FIR No. **44** dated 07.03.2013 U/s 379 IPC PS-03 Chandigarh. The accused arrested in case FIR No. 112 dated 09.03.2013 U/s 473,411 IPC PS-17 Chandigarh by ASI Ranbir Singh.

The accused is on Police remand upto 14.03.2013 and during investigation the accused confessed that he along with his other associate Vikas S/o Joginder Singh R/o Village-Kaimbwala Chandigarh had snatched a purse near Kala Bhawan Sector-16, Chandigarh on 01.03.2013 from a lady, tried to snatched a purse from lady near Aroma Hotel on 08.03.2013, stolen other M/cycle from outside DAV collage Sector-10 Chandigarh, a M/cycle from parking Guru Gobind Singh Sector-26 Chandigarh, stanchings from Pkl & Mohali. On 12.03.2013 at about 3.PM near wine shop Kaimbwala, Chandigarh other accused Vikas S/o Joginder Singh R/o Village-Kaimbwala Chandigarh arrested by ASI Ranbir Singh by the Police party land by SI Harminderjeet Singh I/C, PP-ISBT Sector-17 Chandigarh. The accused Dharmbir is 26 yrs of age, educated upto 10+2th class and working as mechanic of two wheelers in Kansal. Accused Vikash is 23 yrs of age, educated upto 10th and is unemployed. As per record of a MOB they have been found previously involved in the following cases:-
