CHANDIGARH POLICE BUSTED A GANG OF VEHICLE LIFTERS : 05 CASES SOLVED : 02 ARRESTED

Chandigarh Police has achieved a success in arresting 02 accused involved in vehicle-theft cases. On 06.09.2013, acting upon a secret information, a team of the Crime Branch manned a trap near turn Sector-48, leading to Village Jagatpura (Pb), and apprehended accused namely Ashok Kumar s/o Balkishan r/o # 1617, Phase-10, Mohali (Pb) and Ramu @ Raju s/o late Chuni Lal r/o Kamla Nagar, near Rura Railway Station, Distt Kanpur (UP) presently residing near Gurdwara, Village Jagatpura, Distt Mohali (Pb). During the course of investigation, it has been revealed that both these accused used to steal vehicles & alloy-wheels of the four-wheelers (Cars) from different parts of the city. Prior to this, accused Ashok Kumar has been arrested in 05 cases of vehicle-theft registered with different police stations of the city.

Till so far, 01 Hero Honda motorcycle and 10 alloy-wheels of cars have been recovered from their possession. Apart from this, 01 Santro Car and 01 Maruti-800 have also been recovered from the possession of accused Ashok Kumar which have been taken into possession u/s 102 Cr.P.C. A detail of the worked-out cases is as under: -

Further, efforts are being made to ascertain that from where the vehicles taken in possession u/s 102 Cr.P.C were stolen by the accused persons.

On 11.09.2013, both the accused were produced in the court of Sh. T.P.S Randhawa, JMJC/Chandigarh, from where they have been sent to judicial custody for 14 days.
