# City police claim to solve six cases with arrest of four

Accused were involved in robbery, snatching, vehicle-lifting, drug-peddling cases

#### CHANDIGARH, APRIL 21

The Crime Branch of the Chandigarh Police arrested a gang of four persons who were allegedly involved in robbery, snatching, vehicle lifting and drug peddling cases. The accused have been identified as Vikram, alias Vicky (23), and Devinder Singh (19) of Mohali, along with Abhishek Chaudhary, alias Avi, alias Badri (20), and Arun Kumar (24) of Chandigarh. The police have claimed to have solved six cases with these arrests.

On April 17, the police team acting on a tip-off, apprehended Vikram and Devinder while they were coming from the Dhanas lake side on a motorcycle. During search of both accused, one mobile phone was recovered from their possession. The phone was found to be a snatched one and a case in this regard was registered Sarangpur. Further, during interrogation of the accused, it was

revealed that they are also involved in another case of vehicle theft involving an Activa scooter.

On Friday, Abhishek was

arrested at a checkpoint near the Sector 14/25 road to Dhanas. During the search, a mobile phone and a knife was recovered from his possession. The phone was found robbed in a case registered in Sarangpur. Further, during the course of investigation, two cases, one of snatching of a mobile phone and another of vehicle theft of a Hero Splendor motorcycle. were also worked out by recovering the stolen property from the possession of Abhishek.

In an another incident, on April 18, while a team was on a patrolling duty in the market of Sector 44-D. Arun was apprehended and was in possession of 21 gm of heroin without any license or permit. A case under Section 21 of the NDPS act was registered against him. Vikram and Arun were produced in a court and sent to two-day police remand.

## Soon, snatching to invite stricter punishment in city

On HC order, ASG asks Centre to take call on UT proposal to amend IPC

In what appears to be a step forward for much-awaited harsher law provisions for snatchers, who are striking at will in the city for the past some time, the Additional Solicitor General (ASG) of India, Satva Pal Jain, has asked the Union Government to amend the law provisions for enabling a stricter punishment to snatchers in Chandigarh.

The development assumes significance as the UT Administration had been seeking addition of Sections 379-A and 379-B in the Indian Penal Code (IPC) in Chandigarh on the pattern of Punjab and Harvana but the Centre was sitting on the matter.

It was on April 3 that the Punjab and Haryana High Court, which is hearing a petition on the increasing chain snatching incidents in Chandigarh, had directed the UT Administration to supply to the ASG for taking up with the Centre the set of papers regarding enhancing the punishment for snatch-



## WHAT THE PRESENT LAW SAYS

Presently, the snatchers in Chandigarh are booked under Section 379 of the IPC, which provides the maximum punishment of three years in jail or with fine or both.

### PROPOSED LAW

As per the state amendments made by Punjab and Harvana in the IPC for their respective states. Section 379-A provides for a minimum jail term of five years and the maximum of 10 years with fine (Haryana ₹25,000) (Punjab ₹10,000) for snatching while Section 379-B provides for a minimum jail term of 10 years (Haryana maximum 14 years) and fine (Haryana ₹25,000 and Punjab ₹10,000) for also causing hurt to the snatching victim.
