MINUTES OF THE SAMPARK SABHA HELD ON 25.07.2015 AT POLICE LINES, SECTOR- 26, CHANDIGARH UNDER THE CHAIRMANSHIP OF WORTHY INSPECTOR GENERAL OF POLICE, UNION TERRITORY, CHANDIGARH.

A Sampark Sabha was held on 25.07.2015 at Police Lines, Secto ~26, Chandigarh under the Chairmanship of Worthy Inspector General of Police, Union Territory, Chandigarh. The following officers were also present in the Sampark Sabha:-

- 2. Approximately 1000 Chandigarh Police Personnel from the rark of Constable to Inspector from various units i.e. PHQ. Police Stations, Police Posts, PCR, Traffic, Security, Communication, Crime Branch, CCIC, Police Lines, CID, IRBn etc. including Class IV employees/Ministerial Staff and Home Guards attended the Sampark Sabha.
- 3. The proceedings of the Sampark Sabha was started by Inspector Parvesh, I/c PEB, with the reading of Action Taken Report on all the points of last Sampark Sabha held on 03.01.2015.
- 4. Sh A.S. Cheema, IPS, Deputy Inspector General of Police, Chand garh then addressed the police personnel and narrated the achievements/works lone during the year 2015.
 - (a) W/DIGP started with training/courses mandatory for promotion of SI/ASI/HC and told all the present officers/officials that more than 250 personnel (40 ASI have already done Upper School, 123 HC already done their Intermediate school and 48 ASI are doing Upper School and 52 HC are doing Inter School and total 90 ASI/HC are under training) of various ranks of Police personnel have completed/undergoing promotion training/ course till now. In addition

to this, 40 police personnel have completed Commando Refresher Course from Bahadurgarh.

- (b) The data in respect of various medals/awards to Folice officers/officials is as under:-
 - (1) President Police medal for Distinguish Services to Sh. R.P. Upadhyaya, IPS, Inspector General of Police.
 - (ii) 02 Nos. staff members were honored by Pres dent Police Medal for meritorious services awards
 - (iii) Total of 26 Nos. Administrators Police Medals for Distinguished Services and meritorious Services on 26th January and it is highest in history ever.
- (c) Orderly Rooms are being organized by all Senior Officers on their stipulated dates/time on disciplinary/personal matters. Till now following nos. of police personnel were heard by senior officers:
 - (i) W/IGP = 72 on alternate Friday
 - (ii) DIGP = 167 on every Friday
 - (iii) SSP/UT = 92 on every Monday
 - (iv) Comdt/IRBn = 92 on every Monday
 - (\vee) SSP/Sec. & Tr. = on all working days
- (d) We have a this multipurpose hall in police lines and 70 police personnel have booked this hall this year on various occasions and we have received Rs. 3,48,000/- from the bookings.
- (e) We have two Canteen in Police lines i.e. one wet canteen and the sales proceeds of that canteen is Rs. 5,40,926/- and the profit is almost 91,111/- and secondly subsidiary canteen of grocery like items which we are selling at cheaper rates from market. The proceeds of dry canteen are 1,80,70,550/- and with a profit of 4,14,939/- from the sales.
- (f) House allotment is a very utmost important task and we are doing our best so that allotment can be made to all eligible according to their entitlements. Details of allotment of Folice houses so far is as under:-

DIGP Chandigarh informed that like rewards to the meritorious staff, there is a provision of punishments for defaulters. The details of punishments are as under:-

- (i) Police Complaint Authority has passed strictures against 03 police personnel.
- (ii) A total of 79 Departmental Enquires have initiated during this period.
- (iii) A total of 160 old Departmental Enquiries were disposed off/finalized.
- (iv) 208 Nos. Departmental Enquiries are still pending.
- (v) Out of 160 disposed off/finalized, 58 Major punishments and 13Minor punishments were pronounced/awarded.

In our Police Hospital, a total of 27,359 nos. patients got checked up during the year. Despite our staff and their family members, this figure includes general public of nearby locality too.

02 Yoga camps were organized and about 1500 police personnel attended the camps. Furthermore, 05 medical camps were organized and more than 700 police personnel got check up free of cost during camps.

DIGP Chandigarh informed all the present ranks that Chandigarh Folice too have physical fitness centre and Recreational facility (for reserve police party) in Police lines, Sector: 26, Chandigarh and all can avail this facility to maintain their health and enhance their mental ability/knowledge.

To facilitate the NGOs who are coming from outside Chandigarl, we have created a hostel in Police lines with 10-12 beds with all necessary facilities so that they can be accommodated in a proper manner as we are expecting from other police forces during our visit there.

We till today have already reviewed 17 old cases for compassionate appointments and already forwarded to Chandigarh Administration for decision. In regard to 04 fresh cases of compassionate appointment they are at final stage i.e. medical examination.

In addition to all, we have also appointed son of Late Inspector Sucha Singh as ASI and presently he is undergoing basic training course for P/ASIs.

DIGP, Chandigarh exhorted all the present rank officers/officials to raise their grievances, if any, concerning their service or welfare measures and also to suggest measures for the improvement of police working or any suggestion for overall welfare of the employees and their families.

5. The following issues/matters were raised by police personnel during the session:-

1. SI Baldev Singh 893/CHG (Vigilance)

He once again reiterated his concern of water logging on road in front of House No. 165-168 in Police Lines. W/IGP tolc him that this work pertains to Engineering Wing (Civil Department) and that we are following the matter with Engg. Department. Letters are being sent to Engg. Department to complete the work as soon as possible.

2. HC Satish Kumar 697/CP (Communication Wing)

HC Satish Kumar requested that he got promotion as lead Constable in 6-1-1993 only and in 2010 he had competed stipulated ASI course but promotion of his batch is still in apeyance. Secondly, there is a vacant space surroundings Sector 42 quarters which we can be used for vehicle parking, if leveled.

W/IGP informed that promotion courses are already going on. He informed to all the present police personnel that there is a good news for all constables that Administration have consented that we can go on with Seniority cum merit as pasis for promotion from Constable to Head Constable till 2017.
