Dear Upadhyaya,

As you are aware, the Sardar Vallabhbhai Patel National Police Academy, Hyderabad is the Premier Police Training Institution of our country engaged in imparting basic training to the entrants of the Indian Police Service. Apart from this, the Academy is also conducting a wide array of in-service training courses/workshops/symposiums for the IPS Officers of various ranks. The responsibility to conduct Mid-Career Training Programme (Phase-III, IV & V) and the training of Officers selected to the IPS through LCE, is also shouldered by the Academy.

Further, in the aftermath of 26/11 attack on Mumbai on the directions of Hon'ble Union Home Minister, a Special Tactics Wing (STW) was established by the Academy to train State Police/CAPF officers in counter terrorism/ insurgency tactics and to expose them to practical exercises. Keeping in view of the exponential growth in its training activities, the Academy has recently been sanctioned 274 additional posts resulting in almost doubling of the personnel in the Academy.

With internal security becoming a top priority of government, the training of officers of the Indian Police Service assumes great importance. Lack of sufficient and capable trainers impact quality of training imparted, and this has long time implication on policing across the country.

An Academy which is wholly devoted to the training of the highest echelons of the Indian Police deserves to have the best cream in the field of Policing. May I therefore request you to nominate at least two suitable and willing personnel/trainers of your Force (in the rank of Sub-Inspector to Supdt. of Police) to serve the Academy on deputation basis for a period of three years.
