Subject: - **Award of Administrator's Police Medal for Distinguished Service and Meritorious Service on the occasion of Republic Day-2025.**

As usual, the recommendations are required to be sent to the Chandigarh Administration for the award of Administrator's Police Medal for Distinguished and for Meritorious services on the occasion of Republic Day, 2025 as per eligibility criteria mentioned below:-

Administrator's Police Medal for Meritorious Services

- i) The candidate should have completed 15 years of service with Chandigarh Police as on 1st January.
- ii) The candidate should not have awarded any major punishment during the service.
- iii) There is nothing on record with regard to integrity of the candidate during the service.
- iv) The candidate should not have awarded any minor punishment (i.e **Censure**) during the period of 15 years.
- v) The candidate should not be involved in any departmental enquiry/criminal case and is clear from Vigilance angle.


Administrator's Police Medal for Distinguished Service

The candidate should be a recipient of the **Administrator's Police Medal for Meritorious Service** and would become eligible for consideration only after **three years** of the receipt of this medal.

- i) The candidate should have completed 20 years of service with Chandigarh Police as on 1st January.
- ii) The candidate should not have awarded any major punishment during the service.
- iii) There is nothing on record with regard to integrity of the candidate during the service.
- iv) The candidate should have not been awarded any minor punishment (i.e Censure) during the period of 20 years.
- v) The candidate should not be involved in any departmental enquiry/criminal case.

Citations should not be more than 200 words.

Recommendations/citations, if any, duly recommended by concerned GOs may be sent to this office by **16.12.2024 positively** so that same could be compiled for further sending to Chandigarh Administration well in time. No recommendation will be entertained after stipulated date.
