Subject:- Regarding setting up of Juvenile Cell.

Implementation of Juvenile Justice (Care and Protection of Children) Act, Juvenile Cell created in the Chandigarh. As far as the existence of Child Friendly Rooms in the police stations is concerned, in all the police stations Child Friendly Rooms are existed except P.S.s- Ind. Area, Manimajra, IT Park, Mauli Jagran, Sarangpur, 36 & Maloya. SDPOS of concerned police stations may be directed to set up Child Friendly Room in these police stations. It is further directed that Juvenile Police Officers have been detailed in each police stations of Chandigarh to deal with the complaints/cases of juveniles.
